 Tik Tok	Video-sharing social networking service (such as videos).	<ul style="list-style-type: none"> <li>- Minimum age of 13, but no verification</li> <li>- All content is public by default</li> <li>- Inappropriate language &amp; content</li> <li>- Contact with strangers</li> </ul>
 YouTube	Video-sharing platform	<ul style="list-style-type: none"> <li>- Explicit comments on videos</li> <li>- Inappropriate content spliced into videos on the regular and kid's platforms</li> <li>- Known paedophile problem</li> </ul>
 Tellonym	Anonymous messaging service	<ul style="list-style-type: none"> <li>- Cyberbullying</li> <li>- Threats</li> <li>- Sexual Content</li> <li>- Unmonitored access</li> <li>- Inconsistent age restrictions</li> </ul>
 Bigu	Live-streaming platform	<ul style="list-style-type: none"> <li>- No age verification needed</li> <li>- Users have to provide age &amp; location</li> <li>- Bullying &amp; Violence</li> <li>- Nudity</li> <li>- Inappropriate language</li> </ul>
 IMVU	Avatar-based social platform	<ul style="list-style-type: none"> <li>- 18+ areas with nudity/sexual encounters</li> <li>- Sexual behaviour in non-age restricted areas</li> <li>- Chat features pairs random strangers</li> <li>- All profiles public</li> <li>- Bullying &amp; Grooming</li> </ul>

 Houseparty	Video-chat platform	<ul style="list-style-type: none"> <li>- No screening of video content</li> <li>- Live video, inappropriate content               <ul style="list-style-type: none"> <li>- Chat function</li> <li>- Interaction with strangers</li> </ul> </li> </ul>
 Tinder	Dating/connection platform	<ul style="list-style-type: none"> <li>- Rated 17+ but allows 13+ to join</li> <li>- Geographic locations given</li> <li>- Interaction with strangers</li> <li>- High risk of catfishing, grooming, sexual harassment &amp; stalking</li> </ul>
 Ask.fm	Anonymous messaging service	<ul style="list-style-type: none"> <li>- Cyberbullying</li> <li>- Threats</li> <li>- Sexual Content</li> <li>- Unmonitored access</li> <li>- Inconsistent age restrictions</li> </ul>
 KIK Messenger	Instant messaging service	<ul style="list-style-type: none"> <li>- Minimum age of 17, but no verification</li> <li>- Users can connect with strangers via usernames</li> <li>- Cyberbullying</li> </ul>
 Snapchat	Messaging service	<ul style="list-style-type: none"> <li>- Users share time-limited images (not realising they can be screenshotted)               <ul style="list-style-type: none"> <li>- Sexting</li> <li>- Cyberbullying</li> </ul> </li> </ul>
